Things that I have been working on: Lots to Read!

OGC-Gov't Referrals:

1. Since the BRFN court case, one of the arguments was that Private Lands with oil & gas activities on their property is a contributor to cumulative environmental impacts to our Treaty Rights. Also, ALL new development permits are on hold until all Private Land referrals are dealt with. So, the positive side to that is... reclamation can catch up.

Since the decision the other BC Treaty 8 Nations are giving an opportunity to comment on Private Land applications, so we are getting a Backlog of government referrals and I am finding we

have a lot of TUS overlapping on some. Before we only received notifications on Private Land applications.

For March I received and completed 87 OGC Private Land applications, I had a deadline of March 31st. I had another Batch in April which was 77 OGC applications, due April 29th. I sit at my desk quite a bit lately and do my desktop reviews based on SFN members TUS data in our system. The TREP Team is very busy doing during this time to respond to government referrals. In my OGC reviews and responses the items I mention are:

- 2. Treaty Rights-To make sure that the BC Government upholds our Treaty!
- 3. Environment/Water-To ensure Industry is following their "Best Environmental Practices" when developing on the Land, free from any Hydrocarbons.
- 4. Vegetation-To make sure if they disturb any vegetation that they put back native species plants during the reclamation phase.
- 5. Wildlife-To ensure they are **not** blocking any wildlife corridors or disturbing wildlife habitat.
- 6. Making sure that our SFN members/4EG environmental monitors are participating in assessing proposed projects in our traditional area.
- 7. Promote Reclamation & Restoration for all dormant wellsites, facilities etc.

Crew Energy:

I was asked to do a Saulteau Cultural Awareness Presentation for Crew Energy on April 20th in FSJ. I always take pride in representing my Nation. Crew's O&G activities are in Delrio/Monias area. I work with Matteo Villani from Crew Energy, we meet on a Quarterly basis or as needed, and we both support the Moosehide Campaign which is recognized May 12th. Crew does a good job at pre-engaging & field visits with SFN-we have a great working relationship. Crew does donate to yearly community cultural events and educational initiatives. We do tell Crew of any environmental concerns in Delrio/Monias area. They do submit an annual workplan to clean-up some of their dormant wellsites. This spring-May sometime, we will be planning on a field date and will be harvesting Fiddleheads and cooking some moose meat over a Fire with Crew-so if any member wants to join in, let me know, 2-3 members!

OGC/T8 Restoration Advisory Committee:

OGC/T8 Restoration Advisory committee will be hosting a Workshop for Oil & Gas Industry on May 17&18th in FSJ on The ESSG(Ecological Suitable Species Guidelines) reclamation. This is a Guide for O&G proponents to plant sites with more native plant species on their dormant wellsites. I am hoping we can get Twin Sisters Nursery(Julian Napoleon) involved to give a presentation on what they do. We also promote and support Aski Reclamation

Fish Wildlife & Compensation Board:

There were 23 Fish & Wildlife Proposals approved. 7 Fish & 16 Wildlife studies to be conducted in the 2022-23 Season. Fish Studies funding amount totalled \$388,961. Wildlife Studies total amount is \$646,748. I would like to say Congrats to the Nikanese Wha Tzee Stewardship Society for they got 3 RPF's approved with FWCP, Way to Go!

The FWCP Compensation Program also has a "Community Engagement Grant Community Fund" up to \$1,000 on any small restoration initiative project.





TC Energy and Coastal GasLink celebrate historic equity agreement with Indigenous partners

Delivering a world-class project that will provide economic benefits for Indigenous communities, British Columbians and Canadians for decades to come has been a priority since day one.

Our commitment started nearly 10 years ago, and since that time, we have worked together to identify a path towards mutually beneficial relationships with Indigenous and local communities. These relationships have led to the creation of unprecedented agreements of support from 20 Indigenous communities along our project corridor. It is an honour to have our Indigenous neighbours also be our business partners.

We are proud to announce that TC Energy has signed option agreements to sell a 10 per cent equity interest in Coastal GasLink. The opportunity was made available to all 20 Indigenous communities holding existing agreements with Coastal GasLink and is an important step on the path to true partnership through equity ownership in the project.

"The finalization of the option agreements represents a historic milestone in our desire to participate as equity owners in Coastal GasLink. For many of us, this marks the first time that our Nations have been

included as owners in a major natural resource project that is crossing our territories," states Chief Corrina Leween of the Cheslatta Carrier Nation, and member of the CGL First Nations Limited Partnership Management Committee.

Our Indigenous partners have been instrumental in the construction of Coastal GasLink. Since construction began, we have had hundreds of key roles held by local Indigenous people, and over \$1 billion in project contracts have been awarded to local Indigenous businesses. In 2021 alone, we invested over \$550,000 in local Indigenous communities to support community initiatives, skills training and education.

"We want to be partners; we want to be involved in the life cycle of the project from ground-breaking to reclamation. Having the option to get involved in equity opens up the opportunity to have a long-term economic benefit from a project that will be there for years," said Chief Justin Napoleon of the Saulteau First Nations, and a member of the FN CGL Pipeline Limited Partnership.

We look forward to strengthening our Indigenous partnerships as we take these next steps together in building a lasting legacy founded on safety and respect for all people, communities and the environment.

Wilde Lake: Teamwork leads to incredible progress and community investment

Delivering a world-class project that will provide natural gas to Overseas markets wouldn't be possible without the Wilde Lake Compressor and Meter Station.

Construction of the facility is well underway, with more than 74 per cent of the facility construction complete. Serving as the starting point for clean, Canadian natural gas to be transported to the LNG Canada facility in Kitimat, B.C., the facility is instrumental in the safe operation of Coastal GasLink for years to come.

The facility's construction isn't just the building of the facility; it includes the building of community for the Wilde Lake team. Since the start of construction, the team has

deepened their relationships with the surrounding communities by supporting local organizations, including the Nawican Friendship Centre and Network Ministries. Through 50/50 draws and raffles, the site team has raised over \$22,000 to support these organizations' vital programs. To top it off, they recently raised an additional \$5,000 from recycling proceeds that went towards Dawson Creek's Junior Curling Club.

Adding to the Wilde Lake team's successes, the three compressor buildings have been built, along with the completion of the preliminary alignment of the three compressor units. This means that the team can focus on piping and electrical work in the buildings, and finishing the last on-site welds.

Once in operation, the Wilde Lake facility will initially power the transportation of 2.1 billion cubic

feet of natural gas per day (bcf/d) in Groundbirch, B.C. The project has the potential to move up to 5 bcf/d with the addition of compression facilities along the pipeline.

In the coming months, we look forward to celebrating more milestones as the Wilde Lake Compressor and Meter Station progresses to the second last stage of facility construction with the start of hydrotesting and the final alignment of the compressor units. With the anticipated completion of one of the project's major facilities later this year, we are one step closer to delivering sustainable Canadian natural gas to help lower global GHG emissions.

Women breaking down barriers and bias in the energy industry

Coastal GasLink playing a role in the global energy transition

At Coastal GasLink, we're looking towards the future of not only the local communities and environments where we have the privilege to live and work, but also of the world at large.

Natural gas is the cleanest burning fossil fuel, and we're working with LNG Canada to make it available to global markets, replacing other carbonintensive energy forms.

Liquified natural gas (LNG) is one of the world's fastest growing major

energy sources, and global demand is projected to rise significantly over the next 20 years. It's estimated that natural gas exports facilitated by Coastal GasLink could reduce annual global CO2 emissions by 60 to 90 million tonnes, which is roughly equivalent to removing up to 12 to 18 million cars off the road. This also represents more than the total annual emissions of B.C and roughly 10 per cent of Canada's annual emissions. This provides an opportunity for British Columbia to help replace higher carbon-emitting fuels, such as coal, with cleaner energy sources, contributing to the global effort to mitigate greenhouse gas emissions and reduce air pollution.
